# **Research in Progress**

- "Van High School NR Curriculum Context" (On-Going). (October 25, 2018 Present).

  Van High School Natural Resources Proposal; At an agreed upon date in December, Drs.

  Spong and Owen will lead a brief faculty meeting to launch a school wide, cross curriculum, natural resources based theme planned for January or February 2019.
- As a step to move towards implementation of the P20 project and other connections between Van High School and West Virginia University. Drs. Spong and Owen, representing the WVU Davis College of Agriculture, Natural Resources, and Design and the WVU Extension Service will deliver a charge to the Van faculty to kickstart natural resources education integration into the core curriculum.
- Van, located in rural Boone County, West Virginia is surrounded by forests, streams, wildlife, and a wide range of other natural resources. While the students, faculty, and the Van community all interface with this environment every day, many take these direct interactions with their natural resources for granted.
- In order to highlight these natural resources and the opportunities for appreciating, experiencing, and working with these resources, we propose that Van High selects natural resource based thematic areas to be integrated into every course at the school.
- "Logging Operations Notification, Inspection, and Enforcement Update" (Planning). (March 1, 2018 December 31, 2019).
  - The WV Division of Forestry (WVDOF) and the WVU Appalachian Hardwood Center (AHC) have previously developed the WV Logging Operation Notification, Inspection, and Enforcement System (LONIE). LONIE is an online application designed to facilitate data entry, improve the allocation of limited personnel resources, facilitate the timeliness and accuracy of reporting activities, and provide real time spatial data detailing harvesting activities occurring in the state. This project's primary goals are to update LONIE through the addition of new features, specifically to allow system access for timber owner users to manage their notifications and extend and improve the included mapping tools.
- With LONIE fully integrated into the WVDOF's operations, maintenance and enhancements to the system are necessary to improve usability, incorporate additional features, and to ensure the use of current security and programming best practices and protocols.
